Children's Program: Little Smiles impacted over 23,000 children in 2019 at over 38 pediatric facilities in southeast Florida, central North Carolina and Western New York which includes the FL annual Holiday Toy Drive. The activities that rate the most children year-round include providing emergency comfort food and clothing, and parties inside facilities. LS Florida's Toy Drive served over 9,000 children. Kids received items like a late night meal in the emergency room, a comfortable pair of pajamas, an electronic device or memorabilia from their favorite sports star: all to give them much needed feelings of joy, strength and hope.
